



## 2022 Summer Law Fellowships

For the summer of 2022, the Williams Institute will award 1-2 summer law fellowships. The fellowships provide law students, or recent law school graduates, with a \$5,000 stipend for 10 weeks of full-time work with the Williams Institute.

### Criteria for Selection

Applicants must be current law students (1L, 2L, 3L or LLM). The Selection Committee will consider the following when evaluating applicants: a) academic record; b) research and writing abilities; and c) demonstrated commitment to public interest work, especially work focused on sexual orientation or gender identity law and policy issues.

### Fellowship Award

The Fellowships will provide a stipend of \$5,000 for 10 weeks of full-time work with the Williams Institute to be completed during the summer of 2022.
