## 2023 Summer Law Fellowships

For the summer of 2023, the Williams Institute will award 1-2 summer law fellowships. The fellowships provide law students, or recent law school graduates, an opportunity to engage in research related to LGBTQ law and policy with Williams Institute scholars. Summer law fellows are expected to work full-time with the Williams Institute for at least eight weeks.

### Criteria for Selection

Applicants must be current law students (1L, 2L, 3L or LLM). The Selection Committee will consider the following when evaluating applicants: a) academic record; b) research and writing abilities; and c) demonstrated commitment to public interest work, especially work focused on sexual orientation or gender identity law and policy issues.
