



ArizonaShield Law Fact Sheet

In June 2023, the Governor of Arizona issued executive orders providing shield law protections that bar state agency assistance, arrests, and extradition for investigations into and prosecutions of health care legal under Arizona law. These shield laws may provide limited protection, however, depending on the state's own restrictions on reproductive and gender-affirming health care.

PROTECTION AGAINST OUT-OF-STATE INVESTIGATIONS AND PROSECUTIONS

Protection Barring State Agency/Employee Assistance

Executive Orders issued in June 2023 prohibit state agencies from assisting in out-of-state investigations relating to reproductive health care and gender-affirming health care that would not be punishable under Arizona law.¹

Protection against Extradition and Arrests

Executive Orders issued in June 2023 provide that, to the extent permissible under Arizona and federal law, the administration will decline requests for arrest or extradition seeking to prosecute those providing, receiving, or supporting reproductive health care and gender-affirming health care unless the acts would also be punishable as a criminal offense under Arizona law.²
